peen inducted into the IES vide order No.P-5/2016 dated 22.04.2016 of F.No.13016/4/2016-IES.

Officers are from erstwhile Forward Markets Commission which has since been merged with SEBI w.e.f. 28.09,2015. In terms of para 3 of letter F.No.1/18/SM/2015 dated 11.8.2015 of Financial Markets Division, Department of Economic Affairs, these Economic Officers have been taken on deputation by SEBI initially for a period of two years w.e.f. from the date of merger. They have submitted their willingness to be employee of SEBI. Seniority of these officers has been kept intact till they become employee of SEBI. Their name will be deleted from the ISL from the date they become permanent employee of SEBI as SEBI is not a participating Department/Organisation for feeder posts of IES. Although SEBI has submitted proposal to Commodity Derivatives Markets Division, Department of Economic Afffairs for permanent absorption of these officers vide letter No.HRD/OW/2016/0000007930/1 dated 16.03.2016 but final order for permanent absorption has not yet been issued. Names of these officers are, therefore, kept in the ISL.

Seniority of these officers has been indicated in accordance with the ment list of UPSC conveyed to MSME

As per IES Rules, 2008, the condition of educational qualification for induction into the IES through promotion, is applicable for those Economic Officers who have been appointed/regularized on the feeder post after notification of these rules i.e. from 06.06.2008 and onwards.

P.E.O (Programme Evaluation Organisation), Niti Aayog, has now been renamed as RDMEO(Regional Development Monitoring & Evaluation Office).

His name could not be included earlier in the ISL as his case of promotion was kept in "Sealed Cover" due to a court case pending against him. The case has been finalised and opening of Sealed Cover he has been promoted to the post of EO from the date of DPC i.e
