BACKGROUND

Public procurement in India contributes about 30% of the GDP. Due to the magnitude of the spending involved it is of paramount importance that the public funds are spent in the most efficient manner possible. An effective public procurement policy is one of the key factors for continuous long-term economic growth, business competitiveness and best value public services to taxpayers.

While collusive or corrupt conduct may occur during any procurement procedure, whether public or private, certain aspects of the public procurement process render it particularly vulnerable to distortion via anticompetitive conduct. On the one hand, the sheer volume of high value public procurement projects – many of which relate to sectors that have, historically, been prone to anticompetitive conduct – creates attractive opportunities for corruption and collusion. On the other hand, public entities are typically more constrained as to their range of permissible actions than private procurers, because of the highly regulated nature of public procurement, and therefore have limited strategic options available to address these threats.

Since enforcement of competition law began in 2009 in India several cases of bid-rigging in public procurement have surfaced and the violators are accordingly penalized. Hence, the need of the hour is adopting a two-pronged approach of making use of the competition law to bring the violators to justice and undertake competition audit of procurement policies to ensure that the procurement policies themselves do not hinder competition in the first place.

Given the above, Administrative Staff College of India, Hyderabad in association with Scuola Nationalze dell'Amministrazione, Italy is pleased to announce a One Day Workshop on Public Procurement and Competition for Government Officials.

It will help procurement officials to take action once they have a suspicion that rivalry in a bidding process has been artificially reduced.



Alberto Heimler is a professor of economics at the Italian School of Government. He is the Chairman of the Working Party on Competition and Regulation of the Competition Committee of the Organization of Economic Cooperation and Development (OECD). He was director for research at the Italian

Professor Heimler is the coordinator of the procurement programs at the Italian School of Government and lectures frequently on antitrust, economic regulation, public procurement both in Italy and abroad.

streams, including the development of the 2009 Guidelines for Fighting Bid Rigging in Public Procurement and the related OECD Council Recommendation of 2012, the work on transparency and procedural fairness, on SOEs and competitive neutrality, and most recently he has been leading the work on international enforcement co-operation. He has authored numerous Background Notes of the Secretariat on a variety of competition law enforcement and policy topics. Mr. Capobianco graduated in law at the L.U.I.S.S. - Guido Carli in Rome and holds LL.M. degrees from the Law School of the New York University and from the Institute of European Studies of the Université Libre de Bruxelles.
