v Shif R.K. Puri and Shif Chetan S. Jayant both Economic Officers joined w.e.f. 05.11.1996 and 31.12.1996 respectively in the Tariff Commission (DIPP), filed an OA No. 2027/2011 before. Hon'ble CAT, Principal Banch, New Delhi, Tariff Commission under DIPP has been included as a participating Ministry / Department for providing feeder grade to the entry level of IES from the date of CAT's Order, i.e., 19.08.2016. Accordingly, both the applicants are to be considered for promotion to IES against vacancies for the vacancy year 2016-17. Hence, two (02) vacancies (01 SC and 01 General) out of 15 vacancies for the vacancy year 2016-17. have been kept reserved for these two officers, in pursuance of DoP&T OM No. 36012/11/2016-Estt.(Res.) dated 30.09.2016.

Officers have already been inducted into the IES vide order No.P-15/2017 dated 29.12.2017 issued from F.No. 13016/4/2016-IES, however officers at S.No.4 and S.No.5 have not jointed service so far.
