The draft IEL is also available on the website of IES Cadre (www.ies.gov.in).

4. All the participating Ministries/ Departments/ Organisations are requested to invite objections/ suggestions, if any, from the officers and examine the same. Thereafter, they may send a consolidated response to this Department within a period of **20 days** from the date of issue of this OM and latest by 15th July, 2019. Objections/ suggestions received after this period will not be entertained.
