**8. NSCs/KVPs**

Apart from above, NSCs for Rs. 30,000/- were gifted to me by my maternal grandfather Shri Kailash Chand Mahajan in the year 1987 (when I was one year old), which matured on 22.3.1993 amounting to Rs. 60,000/-. These were reinvested in NSCs and maturity amount of Rs. 1,20,000/- received on 23.6.1998.

This was again reinvested and the maturity amount of Rs. 2,44,000/- was reinvested in Kisan Vikas Patras on 25.1. 2004. The Kisan Vikas Patras have matured on 6.1.2014 amounting to Rs. 5,07,520/-. These have been reinvested in NSCs for Rs. 5,10,000/- on 07/01/2014 with the maturity date of 06/01/2019. These KVPs were bought in my name at Chandigarh. These are being regularly mentioned in my Income Tax Returns.

**9. Jewellery, etc.**

In addition to all the above, I am also in possession of jewellery worth Rs. 10,00,000/- (approx.) These small pieces of jewellery have also been gifted to me by my mother, maternal grandparents, relatives and friends on several occasions such as my birthday, family weddings etc.
