**OFFICE MEMORANDUM**

**Subject: Nomination of Indian Economic Service (IES) officers for participation in the mandatory Mid-Career Training Programme (MCTP) Phase-II with the Indian Institute of Management, Bengaluru (IIM-B) to be held from 27<sup>st</sup> August – 21<sup>st</sup> September, 2018.**

This Department, being the Cadre Controlling Authority for officers of the Indian Economic Service (IES), is organizing the mandatory Mid-Career Training Programme (MCTP) Phase-II for IES officers with Indian Institute of Management-Bengaluru (IIM-B) to be held from 27th August to 21st September, 2018, including the following:

- i. Three-week Domestic Learning Component (DLC) at IIM-B to be held from 27th August to 12th September, 2018, and;
- ii. One-week Overseas Learning Component (OLC) being organised by IIM-B at University of Maryland, Washington D.C., U.S.A. to be held from 17th-21st September, 2018.

The IES Cadre will bear the tuition fee; airfare including cost of return ticket (Business/Economy class as applicable for individual officers) from Delhi to Washington Dulles International Airport and back and airport tax, if any; cost of local travel from airport to the University/hotel and back while in U.S.A. (reimbursable on production of receipt), if no transport facility is provided by the University; and also pay admissible per diem Foreign Daily Allowance (FDA) to the participants at the applicable conversion rate as per the extant guidelines of Ministry of External Affairs. However, only TA/DA of the nominated officers, as applicable, for local travel to and back from Airport; and for air travel from Delhi/place of posting to Bengaluru and back, is required to be borne by the respective Ministry/Department/Organization.

4. It may be noted that as per DoPT's guidelines the instant Training Programme is a mandatory training programme. Further, it entails detailed and advance planning in terms of tying up with partner institutions and faculty resources etc. and also involves considerable financial commitments. The concerned Administrative Ministries/Departments/Organizations are, therefore, requested to ensure that the nominated officers are relieved on time to enable them to participate in the Programme. It may kindly be noted that in case of non-participation, action as appropriate may be taken by the Competent Authority.
