2. IES Cadre will bear the Programme fee and the cost of accommodation. The TA/DA of the nominated officers, as applicable, for travel from Delhi/place of posting to Kozhikode, and back is required to be borne by the respective Ministry/Department/Organization as per extant rules.

3. It may be noted that as per DoPT guidelines the instant Training Programme is **mandatory** in nature. Conducting such training entails detailed and advance planning in terms of tying up with partner institutions and faculty resources etc. and also involves considerable financial commitments. The concerned Administrative Ministries/Departments/Organisations are, therefore, requested to ensure that the nominated officers are relieved on time to enable them to participate in the Programme.

4. It may also be noted that in cases, where the officer is not attending the MCTP, Phase-I programme despite being nominated **at least three times**, by the IES Cadre, the officer

would be debarred from all domestic and foreign in-service training/ exchange programmes conducted by the IES Cadre for the next five years.
