3. It may be noted that as per DoPT guidelines, the instant Training Programme is **mandatory** in nature. Conducting such training entails detailed and advance planning in terms of tying up with partner institutions and faculty resources etc. and also involves considerable financial commitments. The concerned Administrative Ministries/Departments/Organisations are, therefore, requested to ensure that the nominated officers are relieved on time to enable them to participate in the Programme.

4. It may also be noted that the officers indicated as “**Final nomination (i.e., Third time)**” in the table above would **not** be nominated further for MCTP 1.
